Ballyskeagh is a small settlement at the base of the proposed settlement hierarchy. the present housing in Nevin's Row and Sandymount is sufficient for a small rural area and joining the two nodes (as proposed) would be to the detriment of the local area and environment.

Ballyskeagh is an area of historical, environmental and conservational importance. Listed buildings include the Lock Keeper's House and Ballyskeagh Bridge. The Lagan Canal and towpath add to the importance, beauty and recreational facility of the area within the Lagan Valley regional Park.

The area that has been requested to be rezoned for housing is farmland and is in keeping with the surrounding countryside. Parts of the area are prone to flooding on a frequent basis. The surrounding infrastructure (narrow roads, historical bridge. sewage system etc) would not be capable of supporting any new development.

The area is rich in wildlife. Buzzards reside in the surrounding trees and otters have been seen in the canal. Any new development would have a detrimental effect on the local ecosystem.

As a resident in Nevin's Row for nearly 30 years I feel it is our duty as a society to preserve the beauty and richness of our natural environment. and deter housing developers from taking over our fields and spoiling our landscape. for their own monetary gains.
