Reasons for Recommendation						

- The proposal is contrary to Policy TEL1 of the Lisburn and Castlereagh City Council Plan Strategy in that it has not been demonstrated that it will not result in unacceptable damage to visual amenity of the Lisburn Conservation Area, nor has it been demonstrated that the proposal is sited and designed to minimise visual impact.
- The proposal is contrary to criteria (a) of Policy TEL1 of the Lisburn and Castlereagh City Council Plan Strategy in that it has not been demonstrated that the sharing of an existing mast or other structure has been investigated and is not feasible.
- The proposal is contrary to criteria (b) of Policy TEL1 of the Lisburn and Castlereagh City Council Plan Strategy in that it has not been demonstrated that a new mast represents a better environmental solution than other options.
- The proposal is contrary to Policy HE1 of the Lisburn and Castlereagh City Council Plan Strategy in that the proposal would if approved, adversely affect a site of regional importance and impact on the integrity of its setting.
- The proposal is contrary to Policy HE5 of the Lisburn and Castlereagh City Council Plan Strategy in that the proposal would if approved, cause harm to the overall character and setting of a historic park, garden and demesne of special historic interest.
- The proposal is contrary to Policy HE10 of the Lisburn and Castlereagh City Council Plan Strategy in that it has not been demonstrated that the new development would enhance or preserve the character and appearance of the area.
